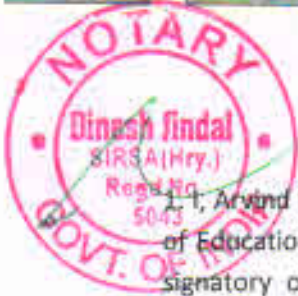

That land measuring 65K-17M detailed above is under ownership and possession of Sirsa Education Society, Sirsa. The Sirsa Education Society, Sirsa had subsequently also taken other adjoining land measuring 6.005 acres (24300 sq. mtrs.) on 99 years lease from Govt. of Haryana as confirmed vide letter no./memo no. 4211-2TCP/83 dated 17.11.1983 and lease deed in that regard was executed and registered by the concerned authority in the favour of Sirsa Education Society, Sirsa at serial no 5699 on 07.03.1984 in the office of Sub Registrar, Sirsa. That area is being used for running CMK National Girls College and allied purposes like hostel etc. Out of land measuring 65K-17M, land measuring 25K-17M earmarked by Sirsa Education Society, Sirsa for establishing National College of Education and on a portion of that land three storey building stands already constructed. Other vacant area is to be used for play ground etc.

3. That the land is on ownership basis. Land is owned and possessed by Sirsa Education Society, Sirsa Building constructed on this land is being used by National College of Education (managed by above said society) for running Teacher Education Course (B.Ed.).

4. That the land is free from all encumbrances.

5. That the land is exclusively meant for running the educational institution and the permission of the Competent Authority to this effect has been obtained vide letter No. 1948 dated 08.06.2007 and a copy thereof is enclosed.

6. That the said premises shall not be used for running any educational activity/institution, other than the teacher education programme.

7. That the copy of the affidavit shall be displayed on the website of the Institution for general Public.

8. I do hereby swear that my declarations under Paras (1) to (7) are true and correct and that it conceals nothing and that no part of this is false.
